BOARD MEMBER COMMITMENTS:

- BOARD MEMBERS WILL BE PROVIDED AN ORIENTATION SESSION WITHIN THEIR FIRST FEW MONTHS ON THE BOARD (IT IS SURPRISING HOW MUCH THERE IS TO LEARN). THE BOARD MEMBER SHOULD BUDGET 3-4 HOURS FOR THIS ORIENTATION.
- BOARD MEMBERS ARE EXPECTED TO ATTEND 80% OF THE BOARD'S SIX MEETINGS IN A YEAR, PLUS A BOARD RETREAT (USUALLY ON A WEEKEND FOR 4-5 HOURS). IF NECESSARY, ATTENDANCE AT THE MEETINGS CAN BE BY ZOOM BUT THE RETREAT SHOULD BE IN-PERSON.
- BOARD MEMBERS ARE ASKED TO SERVE ON A COMMITTEE AND ATTEND 3-4 COMMITTEE MEETINGS EACH YEAR.
- BOARD MEMBER ATTENDANCE AT SPECIAL EVENTS IS ENCOURAGED TO THE EXTENT POSSIBLE.
 REASONABLE PARTICIPATION CONSISTS OF ATTENDANCE AT 4-6 OF THESE EVENTS.
- IN ADDITION TO THE ABOVE, BOARD MEMBERS WILL, FROM TIME TO TIME, BE ASKED TO HELP ON SPECIAL PROJECTS OR WORK INFORMALLY (E.G., CONFERENCE CALLS). TYPICALLY, THIS WILL NOT TAKE MORE THAN A FEW HOURS PER MONTH.
- ALTHOUGH THE AMOUNT IS UP TO THE INDIVIDUAL, IT IS EXPECTED THAT EACH BOARD MEMBER MAKE A CONTRIBUTION TO THE FOOD BANK IN AN AMOUNT THAT IS MEANINGFUL TO THE BOARD MEMBER.
